# A TEAM OF UCLA STUDENTS



LOWELL MILKEN INSTITUTE  
SANDLER PRIZE FOR NEW ENTREPRENEURS

- Two to six members
- At least one member must be an Eligible Law Student:
  - a third-year student, currently enrolled in UCLA School of Law, in good standing, and eligible to graduate with a J.D. degree, an LLM degree or S.J.D. degree in May 2019  
or
  - a graduate of UCLA School of Law who was awarded a J.D. degree, an LLM degree or S.J.D. degree in 2018.



# A TEAM OF UCLA STUDENTS



LOWELL MILKEN INSTITUTE  
SANDLER PRIZE FOR NEW ENTREPRENEURS

- The remaining members must be **Eligible UCLA Students:**
  - a person enrolled at UCLA as a full-time undergraduate or graduate student who is in good standing with his or her school at UCLA
  - Person still eligible even if the person graduates after Dec. 1, 2018.
