The Lowell Milken-Sandler Prize for New Entrepreneurs competition is under way. The competition offers UCLA students with plans for a new venture the opportunity to gain funding for the new enterprise with \$100,000 in prizes - \$70,000 for first place and \$30,000 for second. All UCLA students are invited to participate so the new venture idea could come from a law student, engineering or business student. Each team must include a current 3L, LLM or 2018 Law School graduate.

Have an idea for an app but don't know how to build one? Post for a student with app building skills. Have an idea but don't know how to write a business plan? Use the job board to connect with an interested business school student.
